The black vehicle was dragged for a very short distance before both vehicles came to a full stop as my operator performed a jam brace as I shouted 'stop!'. As I steered to the right, I heard 2SG Jason shout 'stop' and felt a light thud on the HIMARS. I immediately jammed brake and turned the steering wheel to the left. After the incident I drove and parked the vehicle on the left lane, for the HIMARS crew to come down and assess the damages. Brief Details.

On 06/04/2018 at 1435 hrs, I was informed by my subordinate namely 2SG JASON HENG KAI ZE of S9434506E that he was involved in a traffic accident along Yishun Ave 3 towards Sembawang Road as such I immediately proceed down to assist and reached the accident scene at 1440 hrs.

On 06/04/2018 at 1435 hrs, 2SG JASON HENG who was the launcher commander of HIMARS Vehicle Number 21651MID had travelled along Yishun Ave 3 towards Sembawang Road together with two of his crew when he encountered one stationary vehicle of unknown registration number that was parked after the bus stop 59549. Before 2SG JASON instructed the operator namely LCP Lim Zhen Dong Arnold who was driving our HIMARS vehicle to overtake from the right, 2SGT JASON had checked on his right side thus when cleared, he told LCP ARNOLD LIM to overtake. During the overtaking, 2SGT JASON did a second check and saw one black in color vehicle bearing SLK 4833 L (Honda Stream) was beside our MID vehicle.

2SG JASON HENG then shouted stop through our communication system and the operator LCP ARNOLD LIM immediately jammed brake. However it was too late as both of our vehicles had hit into each other as the front portion of our vehicle had hit on the left side of the other vehicle (SLK 4833 L). The said vehicle SLK 4833 L was dragged for about less than 5 metres. Both vehicles then moved to the left side and parked the vehicles to exchange details. It was that juncture that 2SG JASON HENG KAI ZE contacted me to inform of the accident. When I arrived, the unknown stationary vehicle which was parked in front of the bus stop had already drive off and there is no other witness.

I wished to state that our vehicle (HIMARS Vehicle Number 21651MID) has some scratches "right soldier step" just below the right door while the other party vehicle (SLK 4833 L) had dents on the left side of the passenger doors. There is no one injured and no other government property damage.

I wished to state that I am 3WO Wee Jie Hao from 23rd Battalion Singapore Artillery and I had lodging the report for my unit. I wished to add that I was not inside the vehicle when the accident happened.




