Brief Details.

On 24/4/18 at about 0850hrs, I pick up a female passenger (Rogayal Binte Hussian, NRIC No. S1585341G) along Bedok North Road and was heading towards Changi Airport. As I was approaching a bus stop (Bedok North Road B02), I observed that there was a bus driving out from the bus stop. And I also noticed that there was a yellow box (give way to bus) as such I stopped my taxi (registration no. SHC5688Y) before the yellow box. At that juncture, I was telling my passenger that I need to stop before the 'give way to bus' yellow box so that buses can exit from the bus stop.

Subsequently, about 20 - 30 seconds later, I felt an impact coming from the rear of my taxi. I alighted from my taxi and realized that a long (registration no. GBD5227K) had collided into the rear portion of my taxi. The driver of said lorry raised his voice against me, questioning me why did I stopped along the main road. I explained to the driver that there was a yellow box and I should stop for the bus which was exiting. The driver and I exchanged particulars thereafter. And I took several photographs of the vehicles involved.

I started to experience pain on my neck and upper back thereafter. However, I still ferried my passenger to her destination before heading to Mount Alvernia Hospital for a medical examination. I was granted 5 days medical leave from 24/4/18 to 28/4/18. I wish to state that my vehicle was not installed with an inbuilt camera. No government property was damaged.
