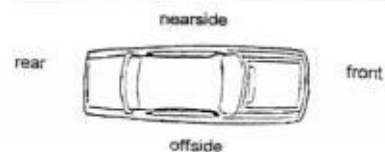

On 3/6/2017 at about 1540 hrs I was riding along ... on the left 3rd lane, an unknown taxi made a wide right turn. The driver going to 3rd lane to proceed to Thompson Plaza, not knowing there is a double white line

Prior to the turn there was a signage to Thompson Plaza, turn to shopping centre when ahead. When the driver made a turn, he was turning very slow and unsure whether he is going in to Thompson Plaza. Also I take note that he was going in to the loading/unloading entrance which is not allowed for taxi. The accident took place when the car was entering the entrance to the loading/unloading. The driver of the taxi then told me that he was sorry me also because his passenger told him to make that turn. Due to impact I hit his right passenger door but the impact was not hard.

I landed in his back of the taxi. I sustained bruises on my right rib, right forearm and right leg. Subsequently, police, traffic police and ambulance came turn to the scene. Sent to HSA.

I managed to stop on time and there is no damaged to his car.

I landed on his back of the taxi. I sustained bruises on my right rib, right forearms and right legs. Subsequently, police and ambulance came down to scene.
