We refer to the KM Auto and LKK reports (see attached).

In the LKK report dd 16 May 2018, it was assessed that 1 rear panel and 2 rear bumper clips are not necessary repairs but did not state why.

The State Counsel is seeking clarifications as to why these repairs are not necessary? E.g. rear panel not damaged etc.

The State Counsel feels that these are the main differences between the KM Auto and LKK reports, and thus the State Counsel will need the reasons from LKK to justify why LKK has omitted these repairs from its report.
