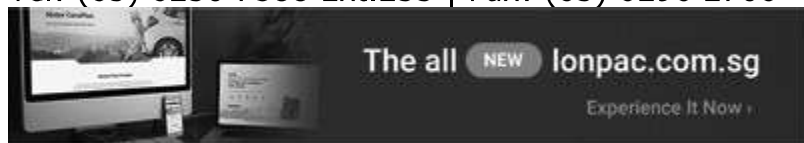
Earlier, Thin Thin advised that the third party agreed to liability at 50%50%.

Please be informed that our principal had further reviewed the matter and still would like to maintain our position on a 50/50 settlement. Our Insured does not have any video footage to support his claim.

Based on the damages profile to both vehicles involved, we are of the view that both vehicles were moving at the time of the accident. Your client's vehicle had sustained an indentation to the rear bumper which suggest that it was a direct hit, similar to the damages observed to our Insured's vehicle which shows indentation to the front left door and no damages of grazing nature were observed.
