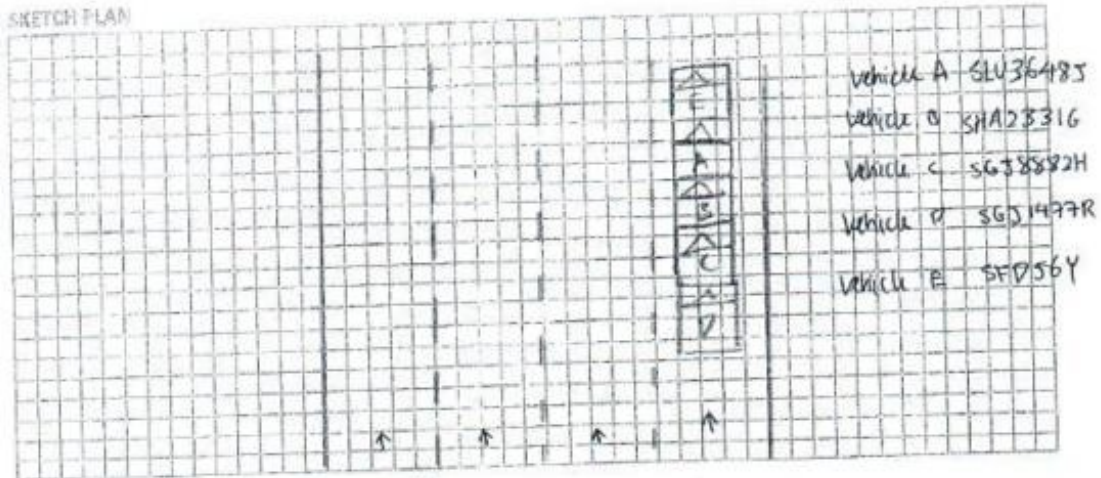

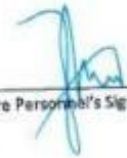
I was travelling along PSE towards Tuas before calling
