Apologies for the late reply as I am overseas from 3 May to 13 May 2018. I have only returned back to Singapore yesterday and received this letter via mail.

Trusted that this is a misunderstanding case of Hit and Run accident on 19 April 2018 at 2235hrs.

The accident happened along Yishun Avenue 2 on 19 April 2018 at 2235hrs, I have stopped my vehicle at the traffic light junction with the other party vehicle FBG294H in front of me. While

moving off, my vehicle had touched the said vehicle FBG294H very lightly. I have stopped my vehicle immediately after that and allowed him to take photos of my vehicle from front, side and back.

If this is a hit and run accident, I would not have stopped my vehicle for more than 5 minutes allowing the other party to take photographs of my vehicle from various angles.
