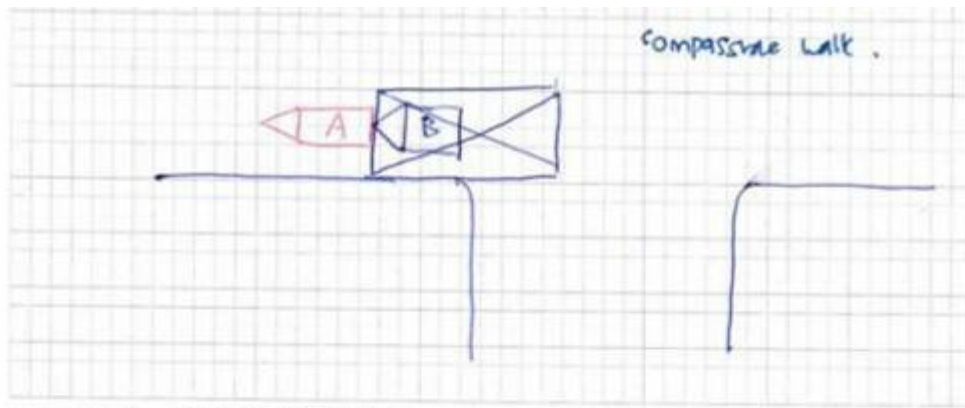
ACCIDENT INVOLVING VEHICLES SKQ 6345X AND SHC 8346P ON 04/05/2018

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
