The Lorry (XD9525M) had rear ended onto my vehicle. I exchanged details with the Lorry driver and later went to Mount Elizabeth Novena hospital to seek medical treatment. I was given three days of medical leaves. I was diagnosed with Sprain and strain of cervical spine.
