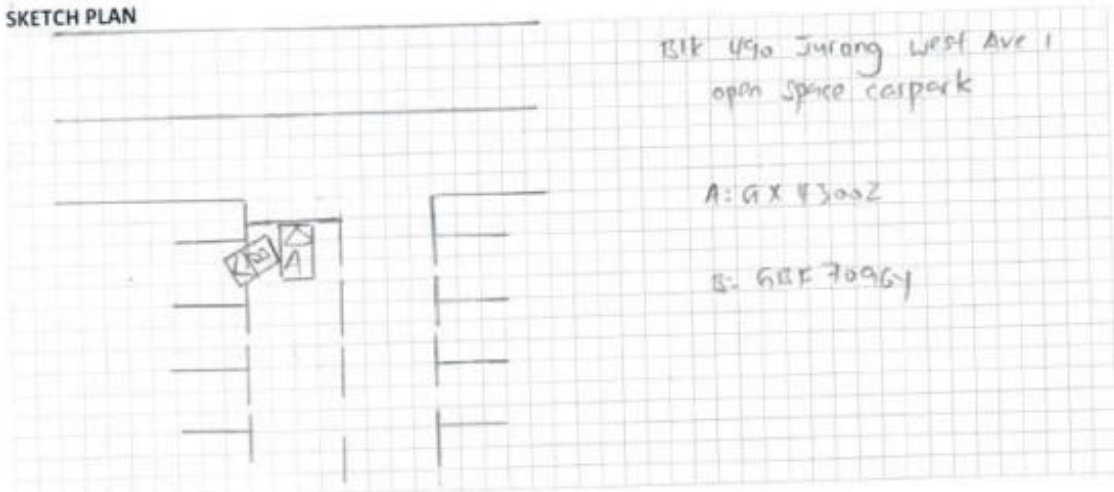
Accident Sketch Plan

open space carpark

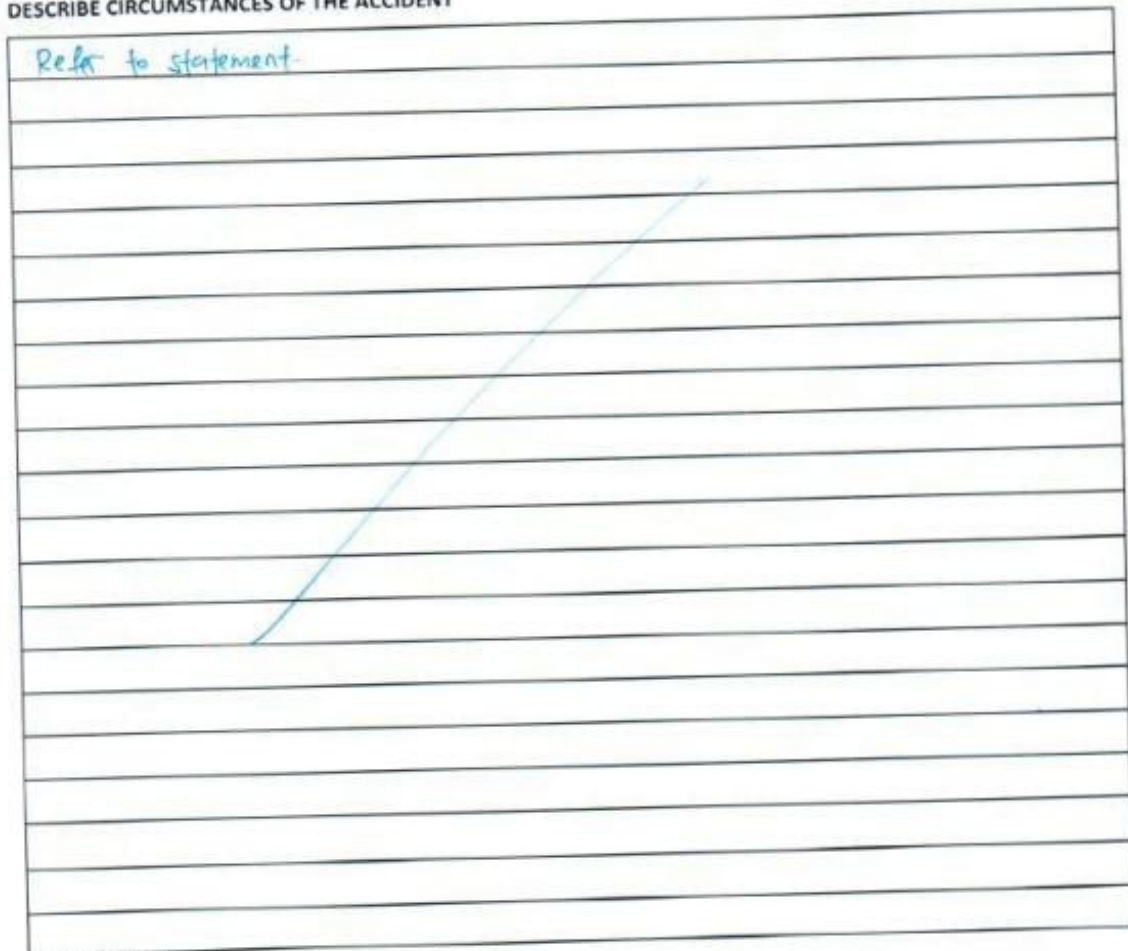
