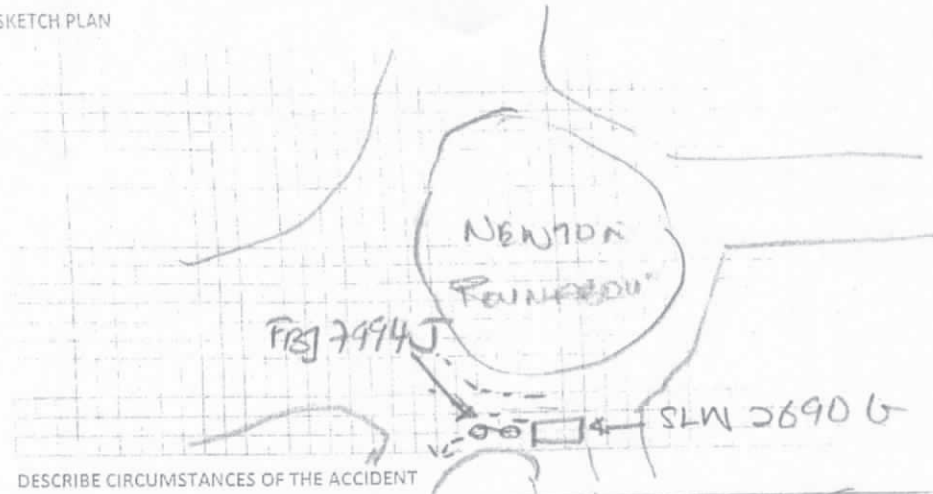


I refer to the above accident.
