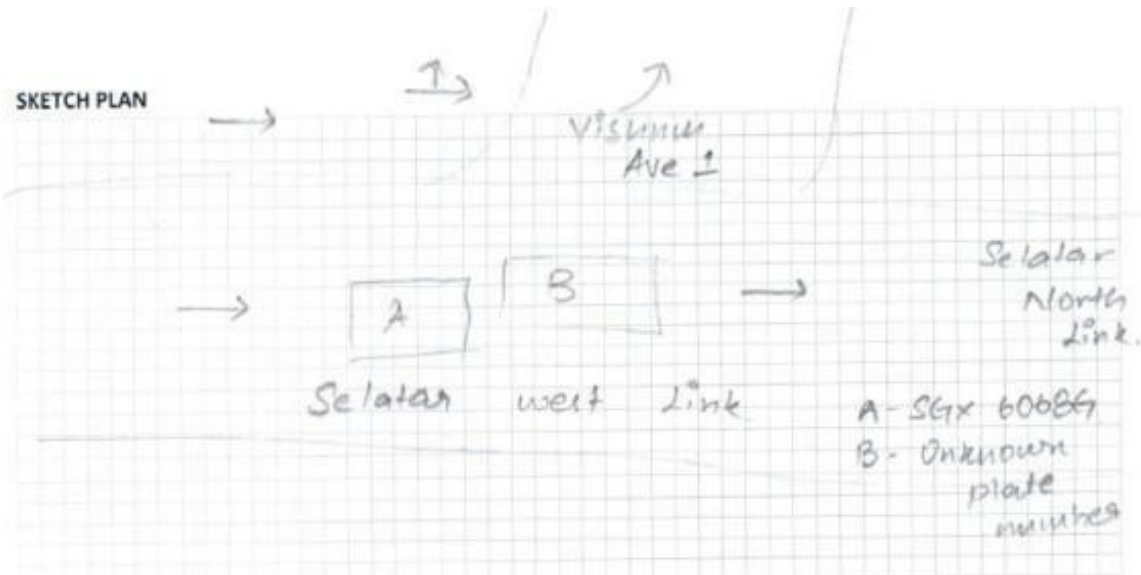




On 10<sup>th</sup> April 2018 at about 7.30pm to 8.00pm
