2. We note that the quota for cars and motorcycle are currently filled. Would appreciate if this email serves as 1<sup>st</sup> approval done (HI) and place on KIV till quota available. Please advise.

3. Case IAFP-IB-20180108-Mechanical Inspection of vehicle SLA7573U (SIO Dzul Hairie - FAIT)

On 6 January 2018 at about 9.04pm, police received a call regarding an accident along Yishun Ave 1 towards the direction of Yishun Dam - L/P 49. It was later established to be a Critical turned Fatal involving one motorcycle - FBH4918K and a motorcar, SLA7573U along Yishun Ave 1 towards the direction of Yishun Dam, near lamp post 49. The said motor car made a U-turn along the said location resulting in a collision with

a motorcycle who was travelling straight on the opposite direction of the said motor car. As a result of the accident, the rider was conveyed in an unconscious state by ambulance to Khoo Teck Puat Hospital (KTPH) while his pillion were conveyed with minor injuries without seeking any treatment. On 7 January 2018, at about 4.08am, the rider succumbed to his injuries and was pronounced dead by Doctor Malcom Mak at KTPH.

4 Case IAFP-IB-20180108-Mechanical Inspection of vehicle JSF7518 (SIO Vilton Hia - FAIT)

On 2.1.2018 at about 9.39 am, motorcyclist was travelling along AYE(MCE) on the lane 1 of 3 lanes road where near to 16.2km, she was seen wobbling and veered to her left before collided onto the left concrete wall. She was pronounced dead in hospital after conveyance from the scene.

5 Case: IAFP-IB-20180109-Mechanical Inspection of vehicle, Prime mover XE1469P(TP/IP/29951/2017) – (SIO Yazid - FAIT)

On 12/06/2017 (Monday) sometime before 1859 hrs, prime mover was travelling along Sims Avenue and at the junction of Lorong 13 Geylang Road collided onto the deceased (cyclist) on PAB who cycled from prime mover right to left and came in front of the motor tipper. Thus, when the prime mover moved forward, the tipper ran over a power assisted bicycle and the deceased. The cyclist died on the spot.

6 Case: IAFP-IB-20180109-Mechanical Inspection of vehicle, motor taxi SHD9602M (TP/IP/00793/2017) – (SIO Mohd Shahril - FAIT)

On 4 January 2018 (Thursday) at or about 12.45 p.m., the Involved Party was driving motor taxi, SHD 9602 M, on lane 1 of the 2 lanes road when he collided into the Deceased (pedestrian), who had walked down from the pavement and was about to cross the road from his right to left. The Deceased was conveyed in a critical state to Tan Tock Seng Hospital by ambulance. She succumbed to her injuries and pronounced dead at the hospital A&E at 1.25 p.m.
