May I seek your assistance to perform a detailed mechanical inspection of the vehicles below.

Case IAFP-IB-20180131-Mechanical Inspection of vehicle SLQ4888Y (SIO Vilton Hia - FAIT)

On 27 January 2018 at about 4.44 pm, the deceased (pedestrian) was crossing the road along Tiong Bahru Road towards Outram Road when the accused driving his motor car SLQ4888Y had collided onto his right side on the 1st lane of 2 lanes road. The deceased was conveyed to SGH by the ambulance, succumbed to his injuries and was pronounced dead in SGH on the same day.

Case IAFP-IB-20180131-Mechanical Inspection of vehicle FBH8186G (SIO Yazid - FAIT)

On 28 January 2018 at about 5.34 am, the deceased (motorcyclist) was believed to have lost control of his motorcycle while negotiating a left bend along Seletar West Link towards Seletar North Link. The deceased sustained serious injury and was pronounced dead at the scene.

Case IAFP-IB-20180131-Mechanical Inspection of vehicle JSC1471 (SIO Yazid - FAIT)

On 28 January 2018 at about 6.53 am, the deceased (motorcyclist) had lost control of his motorcycle by veering to his left and collided onto the road kerb along Ang Mo Kio Avenue 5 towards Buangkok Green. The deceased was conveyed to TTSH by the ambulance, succumbed to his injuries and was pronounced dead in TTSH on the same day.
