On 10.05.2018 at about 1340hrs, I was driving my vehicle (A: SLL1839K) along the extreme right lane of CTE towards city direction. I was travelling straight along the road. Vehicles ahead slow down and stopped. I followed suit. While my vehicle was stationary, I felt an impact from the rear of my vehicle and realized it was a chain collision involving a total of 4 vehicles which vehicle (B: SLZ845A) hit onto my rear portion, vehicle (C: SLR2821Y) in turn hit onto the rear portion of vehicle B. Lastly, Vehicle D hit onto the rear portion of vehicle C.
