Brief Details.

On the 11/05/2018 at about 1046hrs, I was driving my vehicle SKD2329M along Raffles Quay. At the junction of Raffles Quay and Marina Boulevard, I was along the last lane turning left into Marina Boulevard. The traffic light signal was green and so I proceeded with the left turn. Suddenly, I saw a taxi SHA3891A appear in front of my lane. I did not manage to see where the vehicle came from, and did not manage to stop in time as well, causing the front of my vehicle to collide into the back left portion of the taxi. After the collision, both drivers stopped and alighted from the vehicle. The taxi had one passenger on board. None of the parties involved were visibly injured. We exchanged particulars and initially I had called for police assistance, however the taxi driver said that he had to go and drove off before any police arrive. Subsequently, I called the police to enquire again, and since no one was visibly injured nor was any government property involved, they advised me to report the accident to my vehicle's insurance company.

After the accident, I felt some pains in my neck and also hands, so I went to see a doctor at Mount Alvernia Hospital. I was given a medical certificate of 5 days.
