

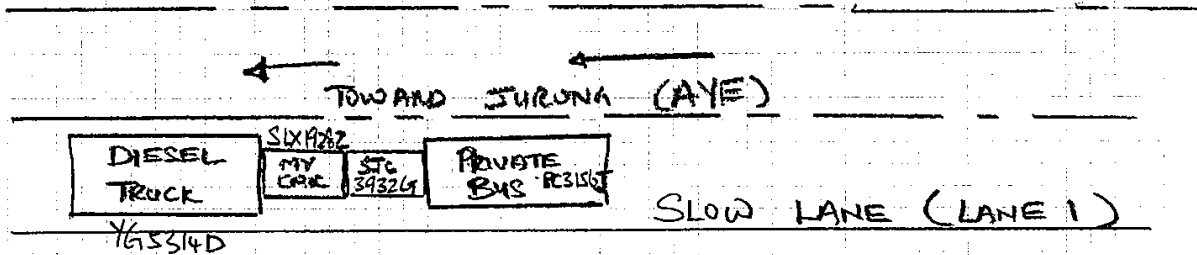

DRIVING TOWARD JURONG ALONG AYE, WHEN DRIVING UP TOWARD THE EXIT OF JURONG ISLAND (FLYOVER), THE DIESEL TRUCK IN FRONT OF MY CAR STOP. I ALSO STOPPED MY CAR (SLX1928Z) BEHIND THE DIESEL TRUCK WITH MY LEG PRESSING ON THE BRAKE. SUDDENLY A CAR (STC39326) HIT THE BACK SIDE OF MY CAR WITH HUGE IMPACT WHICH CAUSED MY CAR TO MOVE FORWARDS AND HIT THE DIESEL CAR. THE CAR WHO HIT MY CAR WAS HIT FROM A PRIVATE BUS FROM BEHIND.
