When I wanted to turn left into the loading bay, I suddenly heard a scratching sound. I then got out of my van and saw that the rear left bumper was in contact with a Blue Hyundai Comfort taxi at its front right bumper. I came out of the vehicle and the driver also came out, walked to the van behind the driver door and used his hand to hit my van a few times. The driver is a Male Malay subject aged about mid 50s. I then approached him and told him to calm down. The security officer then came and told us to settle our problem at the side. I then moved my vehicle so as not to block the traffic. I parked my van in front of his car and after I alighted, I realized that his car was already gone. We only took pictures of each other's vehicles and the damages, however we did not manage to exchange any particulars. I was advised by my company to lodge a police report.

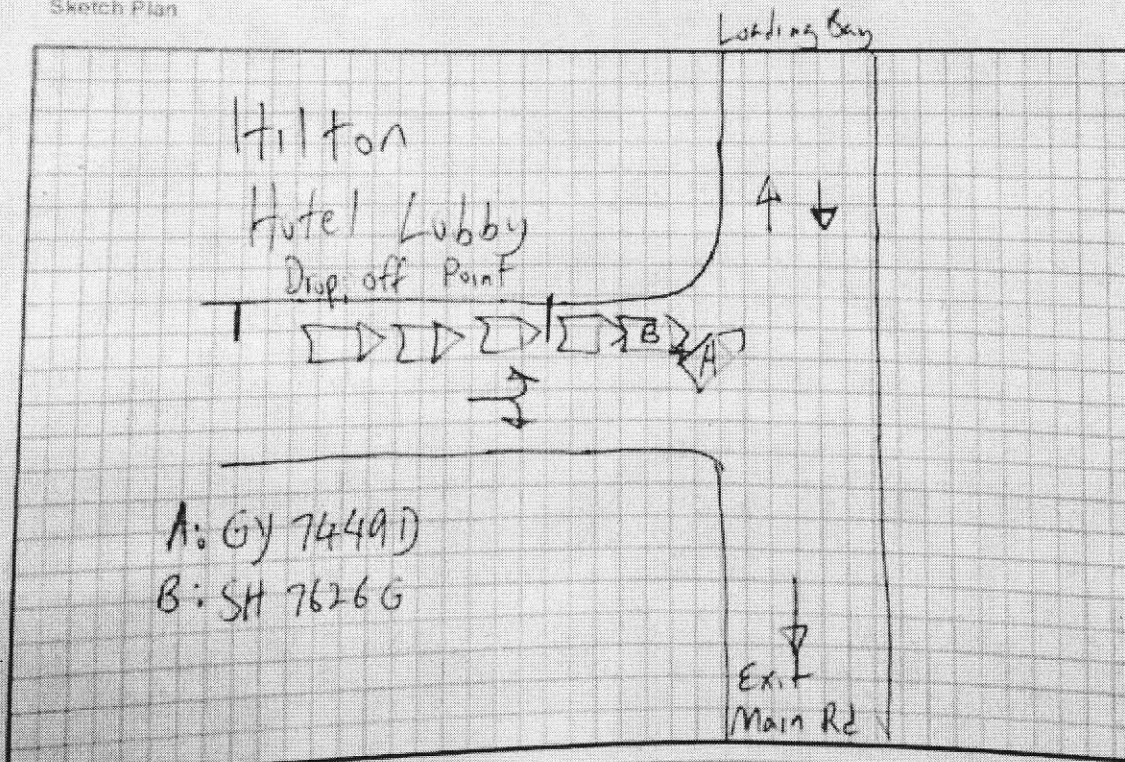

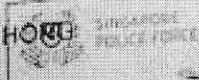
