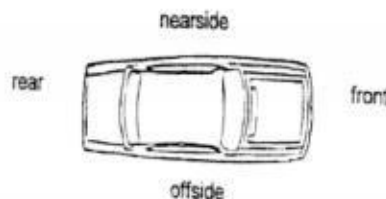

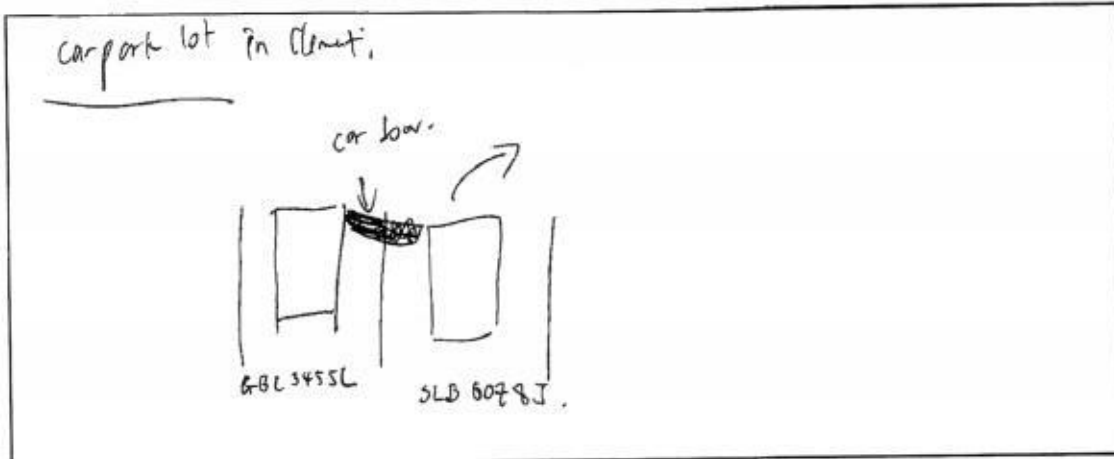

my car C white BMW 216D with license plate SLB 6078J was parked in the open space car park right beside the polyclinic in Clementi. There was a truck (Toyota silver truck, GBC 3455L) parked beside my car.

As I was driving out of the parking lot, the truck on my left dangerously without checking me swung open the car door hitting my car's left passenger side mirror causing damage. The inside of the truck's door hit my side & mirror.

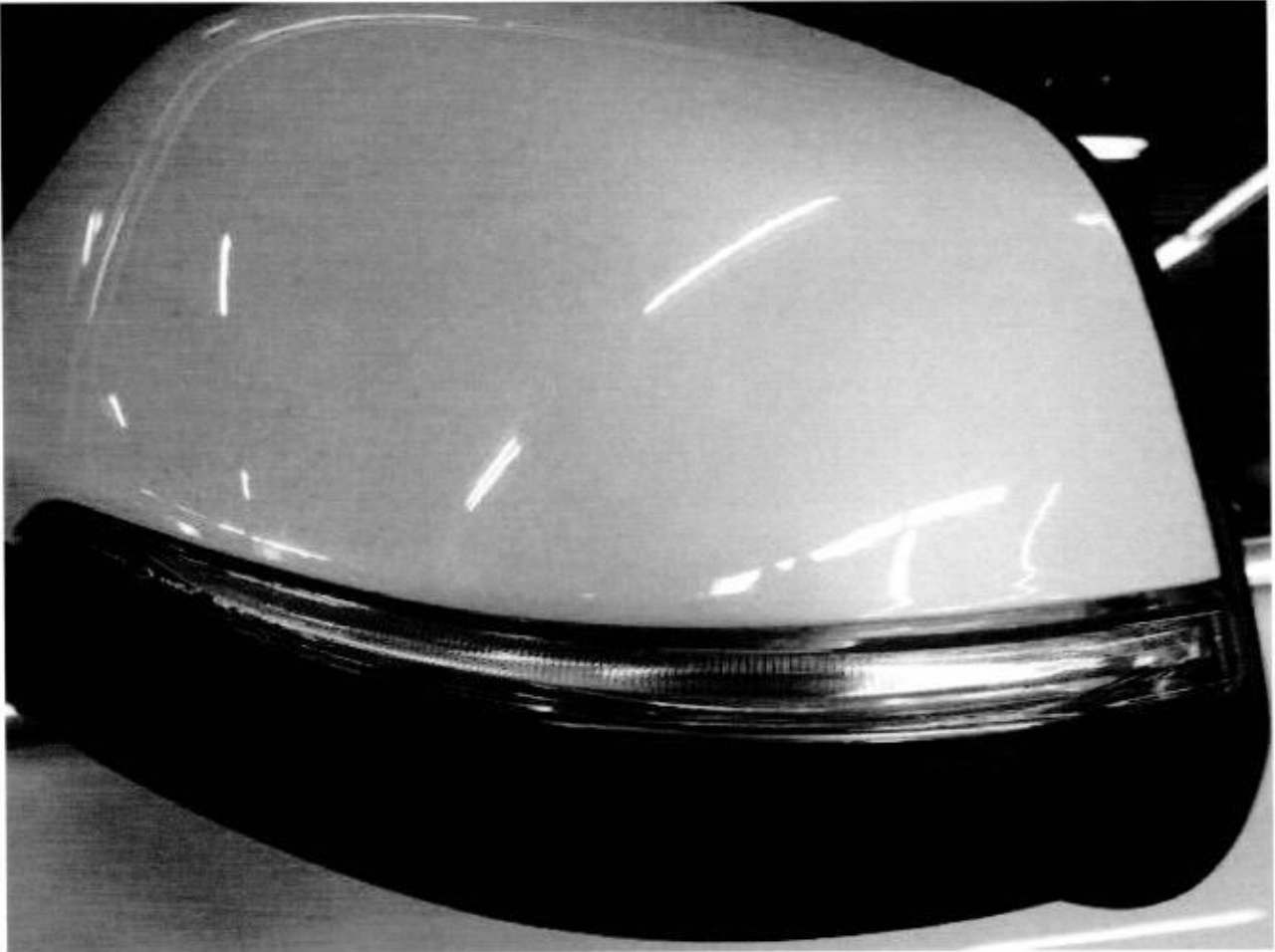

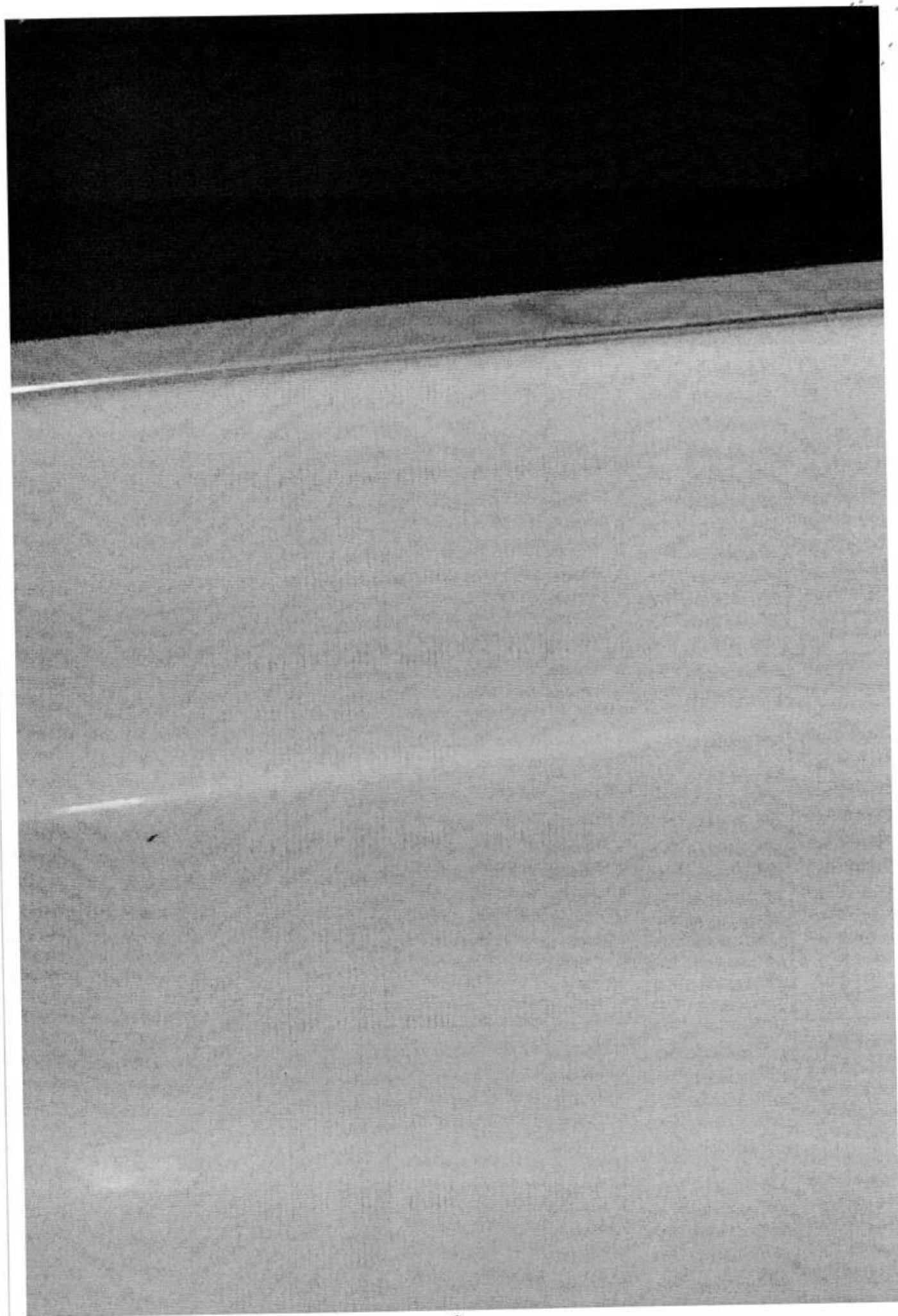
