It was showed clearly that the accident was caused by the Third Party Driver was exiting out from minor road and collided with our insured driver going straight on the main road resulting in this accident. Hence the BOLA scenario 11 (C) should apply arising out of this accident.

Dear Mr. Alfred,

We refer to the above matter.

Please be informed that our offer on 50% basis was rejected. TP wants 100% liability because they are of the view that their hirer's accident statement is more credible as the damage to the taxi is at the front right portion. If based on our Insured statement and sketch plan, the damage to the taxi should be at left front portion.

The accident versions are conflicting. Our Insured driver alleged that he had already completed the U-turn and was moving straight but TP turned from minor road to main road and rear-ended his vehicle. Whereas the TP alleged that collision occurred when he was travelling straight along the centre lane and our Insured made a sudden U-turn. There is no accident video.

We are of the opinion that liability is down against Insured because even though the accident versions are conflicting but based on the damage to TP vehicle, the TP's accident statement is more probable.

We re-seek your approval to offer repairer "TRANS-CAB SERVICES PTE LTD" at **\$6,609.49 (all-in)**.
