TAXI.

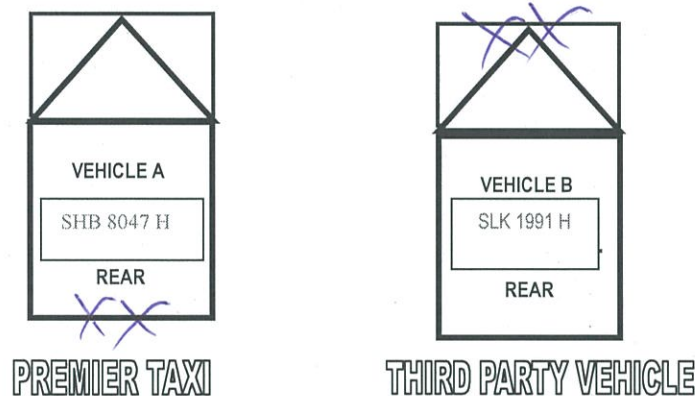
DUE TO THE IMPACT, MY VEHICLE WAS DAMAGED ON THE REAR PORTION AND
