



FACTS OF CASE:

I am the driver of the vehicle bearing registration number YL 1675L which was involved in the accident that occurred on 12/4/18 at 10:55 hours. I lost the CTE and got lost. I went on the way straight out turned right into Tangong Pagar. I was alone. The traffic was moderate. Weather was clear and the road surface was dry.

When I entered the Tangong Pagar Distripark, I made a right turn straight followed by another right. After I made the second right turn I lost control of the vehicle and hit onto 4 parked cars on my right. The left car was a white Volvo bearing registration number SKT 7665A. I hit it on the right rear portion. It was parked head first. An collision caused the Volvo to hit 3 of the cars bearing the number, SK3 4197G, SKL 1570K and 35M 1478H.
