

Describe Circumstances of the Accident

On 15/5/18 at about 10.15am along Leving 32 Geylang Intersection with Guillemard Road traffic lights, both SLH867G and GU9589R were stationary at the red lights.

SLH867G was behind GU9589R.

Driver of SLH867G heard a sound behind and turned back to look. As such, the brake pedal was lightly released which must have moved the vehicle forward very slowly.

SLH867G very lightly touched the back of GU9589R.

Upon accident reporting at World Auto, no damages were found on SLH867G, proving that both vehicles touched / had a very minor contact.
