Brief Details.

I am GRAB Driver. On 08/05/2018 at about 3.40pm, I was driving the car, Maroon/Red colour Mitsubishi Attrage, bearing registration no. SLL7099P, along East Coast Road towards Mountbatten direction. I was approaching the entrance of United Mansion at 592 East Coast Road and made a left turn onto the compound. There was another car exiting the compound and as such I gave way to the car to exit first. As a result, half of my car was still along East Coast Road. Out of a sudden, I felt an impact from the rear. I then saw that a lorry bearing registration no. GY1609Z had collided onto the rear of my car. We took photos and exchange contact details. Nobody was injured and no other property was damaged.

I called my car rental company and was informed to lodge a police report.

Kindly let us have evidences (ie: video footage/ scene photos / PIR) in order for us to look into the matter.
