I WAS TRAVELLING ALONG KPE TOWARDS ECP ON THE LEFT MOST LANE OF A 4 LANE, AS I WAS TRAVELLING STRAIGHT BEFORE THE EXIT TO PIE (TUNNEL), VEHICLE IN FRONT BRAKE AND STOPPED AND I THEREFORE APPLIED MY BRAKE AND SLOWED DOWN, WHEN MY VEHICLE WAS ABOUT TO STOPPED, ONE M/CAR SGV 9796D CAME FROM MY REAR AND COLLIDED ONTO THE REAR OF MY VEHICLE.
