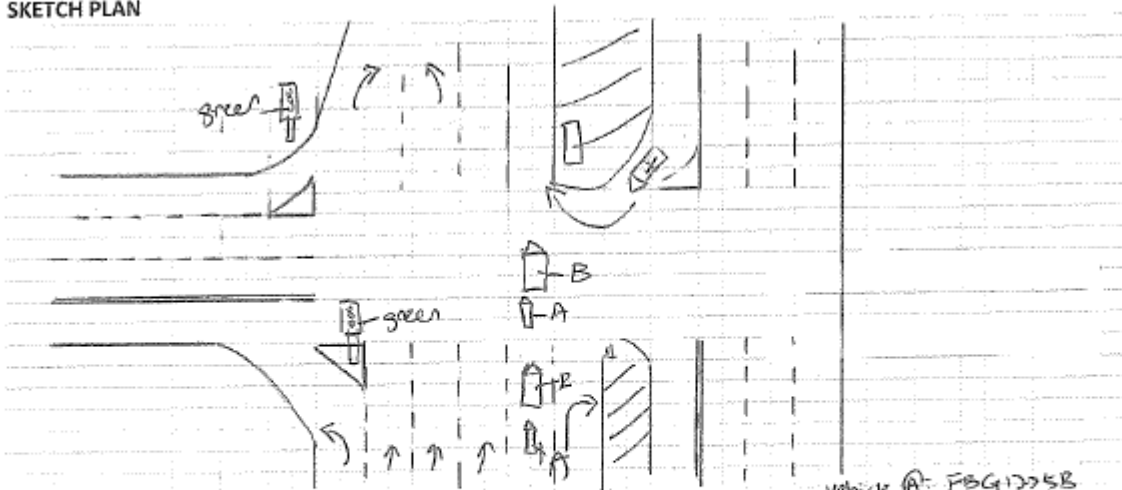

ON 19/04/2018 @ ABT 1830HRS. I WAS WAITING THE TRAFFIC LIGHT CHANGE TO GREEN AT BEHIND OF VEHICLE B (SLK2002G). WHEN THE TRAFFIC LIGHT TURN GREEN, THE VEHICLE B PROCEED TO MO STRAIGHT, AS FOLLOWER, I PROCEED TOO. 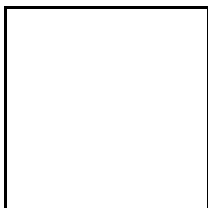
