We just want to clarify if your witness is a co-worker or a fellow worker of the claimant driver as he mentioned "my colleague" in his statement (in yellow below). Muhd Rafee @ Vickneswaran s/o Ramu of NRIC number S8526704C under the employment of Spectra-Teknik (S) Pte Ltd. I was the attendant with Mr Xu Guangli on 18 May 2018. The vehicle, SJK3163S that I was in, was involved in an accident at about 15:15hrs along Ubi Road 1. At the material time, we were heading towards Paya Ubi Road. Our vehicle was travelling on the left lane of Ubi Road 1. Out of a sudden, an impact and bang on the right of our vehicle.
