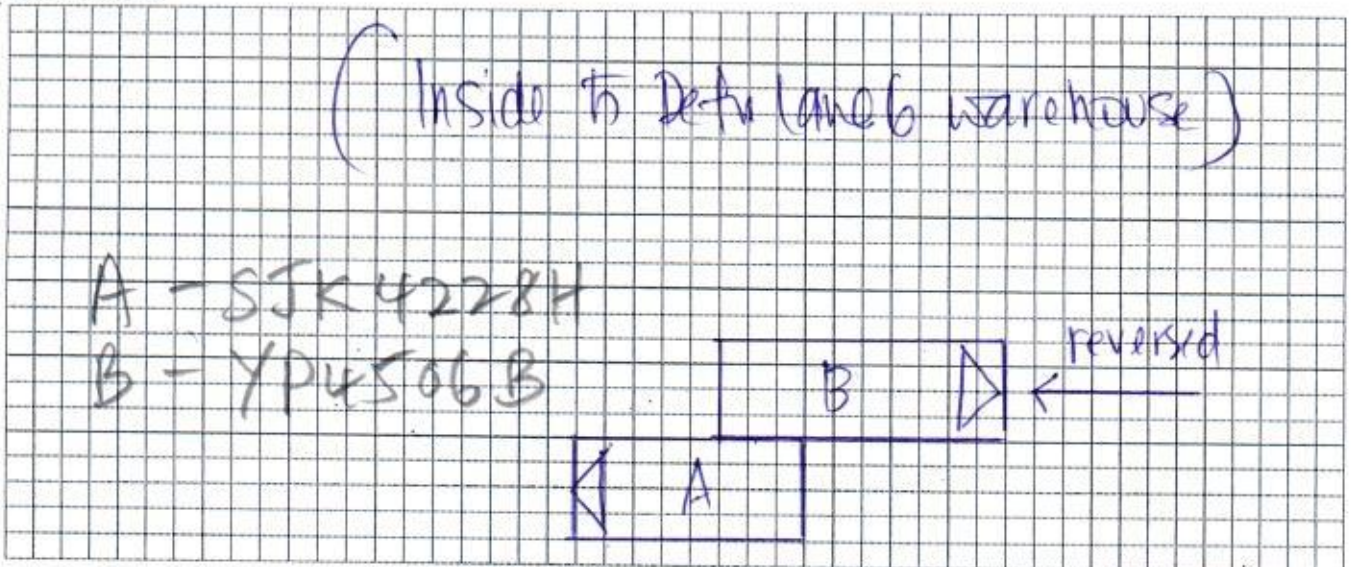


SKETCH PLAN

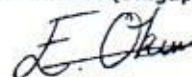
