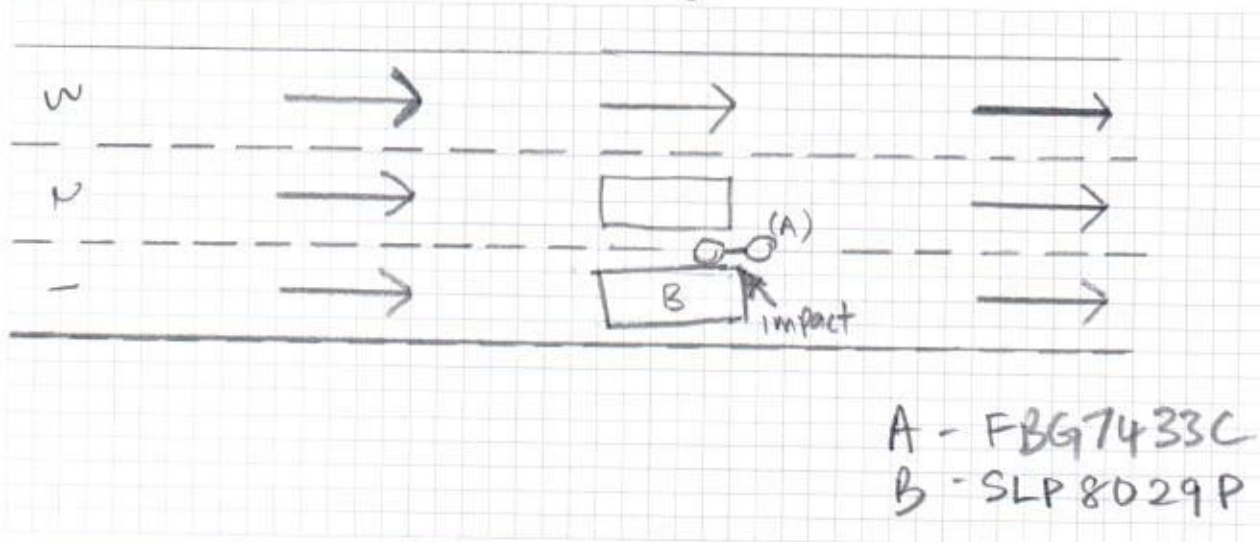

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On the 23/05/2018 (Wednesday) at about 10.40pm, while I was riding along KPE towards TPE near Upper Baya Lekar Exit, I was hit on the rear right side of my motorcycle. I was lane splitting between lane 1 and 2.


Suddenly, I felt my motorcycle wobbled. I looked over my shoulder and noticed that car B was honking and high beaming at me (Car B - SLP8029P). We stopped at the road shoulder which was about 100 - 150m away from incident location. We got down our vehicle to inspect our damage. Car B left side mirror cover was dislodged and there was no damage or broken mirror. There was also a slight scratch on Car B's left front fender. I made a check on my motorcycle and discovered that there is a slight scratch and due to the impact, my right box and its cover was misaligned. While exchanging particulars Car B refuse to provide her driver's license. I had provided my driver's license to her and exchange contact number.


There is no damage to government property or neither of us sustained any injury.


