This vehicle, without warning, (a 3 tonne truck owed by HUATIONG GLOBAL and driven by PEER MOHAMED MUTHU MOHAMED [G6878776P]) knocked into the right side of my car, with loud scraping sound and violet shakes were felt on the car. I slowed to an eventual halt slightly after this incident. Upon stepping out to investigate, I found that the front left protruding tyre rim of the 3 tonne truck rammed into the right rear side of the car. The left front protruding tyre rim of the 3 tonne truck grinded the right rear car rim and also completely punctured the right rear tyre. The passenger door on the right side of the car was also badly scratched and dented by the front protruding tyre rim of the 3 tonne truck On 24 May 2018 the supervisor Vinod called to request private settlement and requested for a quote from a workshop. 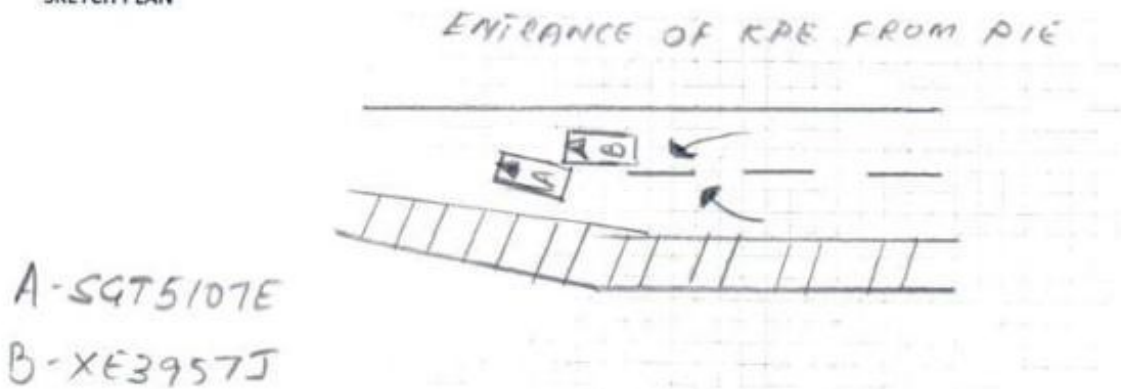

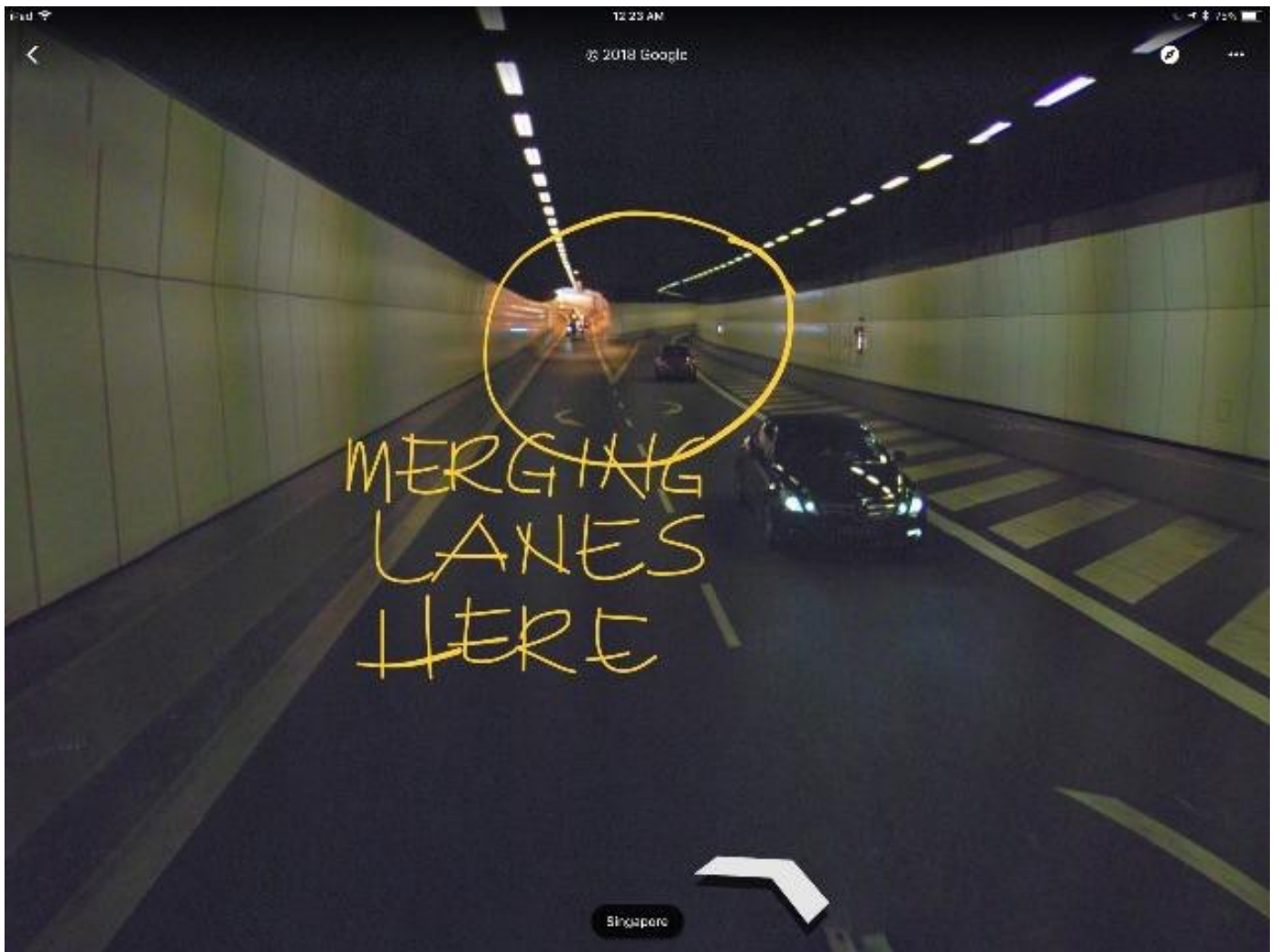

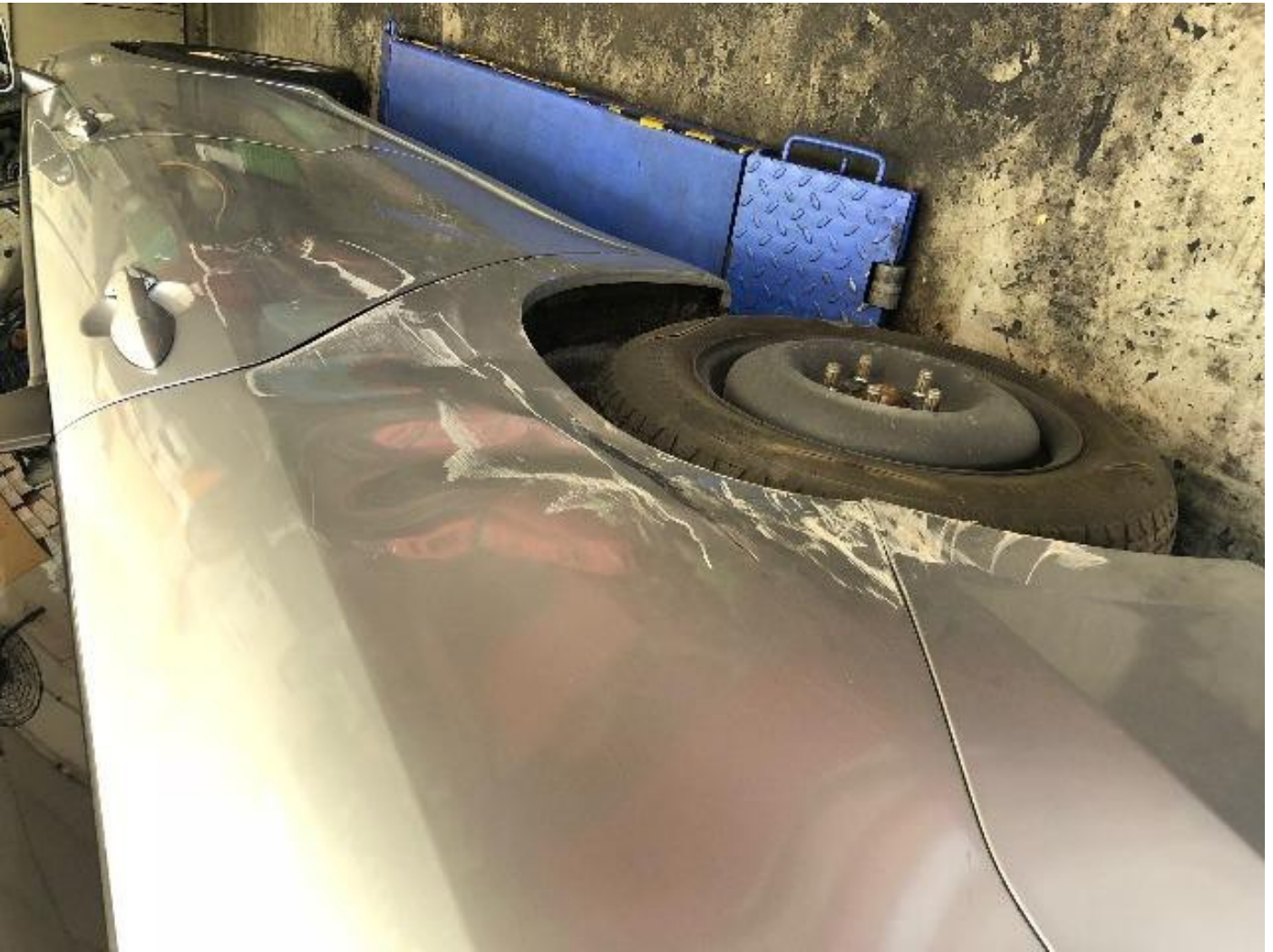
