

### ACCIDENT REPORT - 13 June 2018 - SLN245U George S Kane, S2610232D - the driver

This accident report is being filed after the day of the accident, 23 May, because at the time of the accident I spoke to a man named Jon, whom the driver of SFK8448K said was her son, and we agreed that we will not take the matter to our insurance companies.

The accident occurred on 23 May approximately 2:40 p.m. at Begonia Road near the intersection with Dedap Road. I was parked on Begonia Road on the southbound side just beyond the intersection with Dedap Road. I prepared to leave and advanced about three feet out of the parking lane when I noticed traffic coming from Yio Chu Kang Road, so I stopped and waited for it to pass.

The road at that point bends to the left – see photo - and a driver going south from YCK Road needs to turn left approximately 25 degrees in order to stay on the left side of the road. It appears that SFK8448K driver misjudged the distance on the left side of her car and drove too close to me, resulting in the rear portion of her car coming into contact with the right front part of my car. I was stationary at the time.

I did not lodge a claim against the owner of SFK8448K as repairs to both cars looked quite simple and not expensive. In the case of SLN245U I was correct.

I am a very experienced driver, having grown up and driving in Manhattan, New York City – since age 18, including driving a taxi as a student – and in Philadelphia, Hong Kong, San Francisco and Singapore, on the winding roads of Hong Kong and through snow, icy conditions and fog in NE USA. One learns very early to instinctively be extremely cautious driving in those environments, and where car repairs are expensive. The U.S. Army calls thiis "defensive driving." Have been driving here over 38 years, including continuously since 1990. I have never been involved in a car accident before, anywhere.
