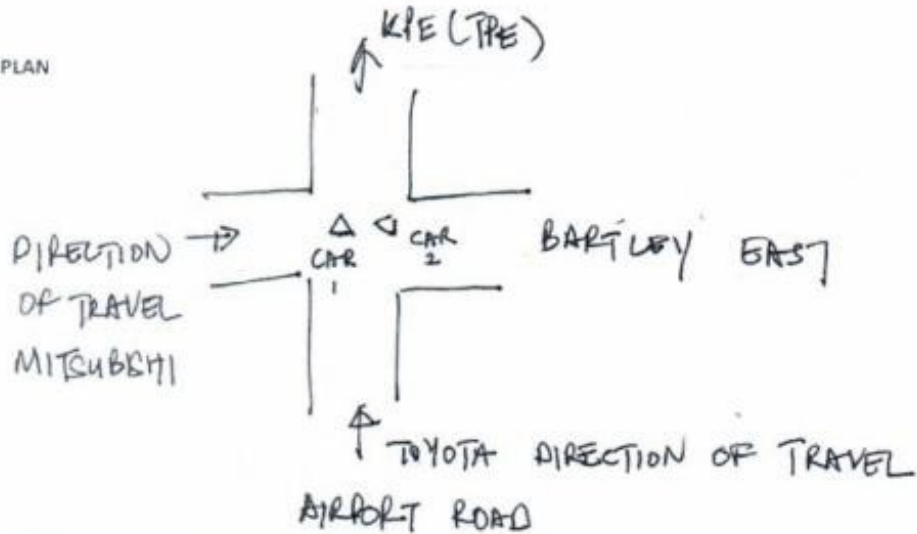

I was informed that the LTA traffic footage can only be retrieved with submission of police report else it will be difficult to ascertain responsibilities of drivers.

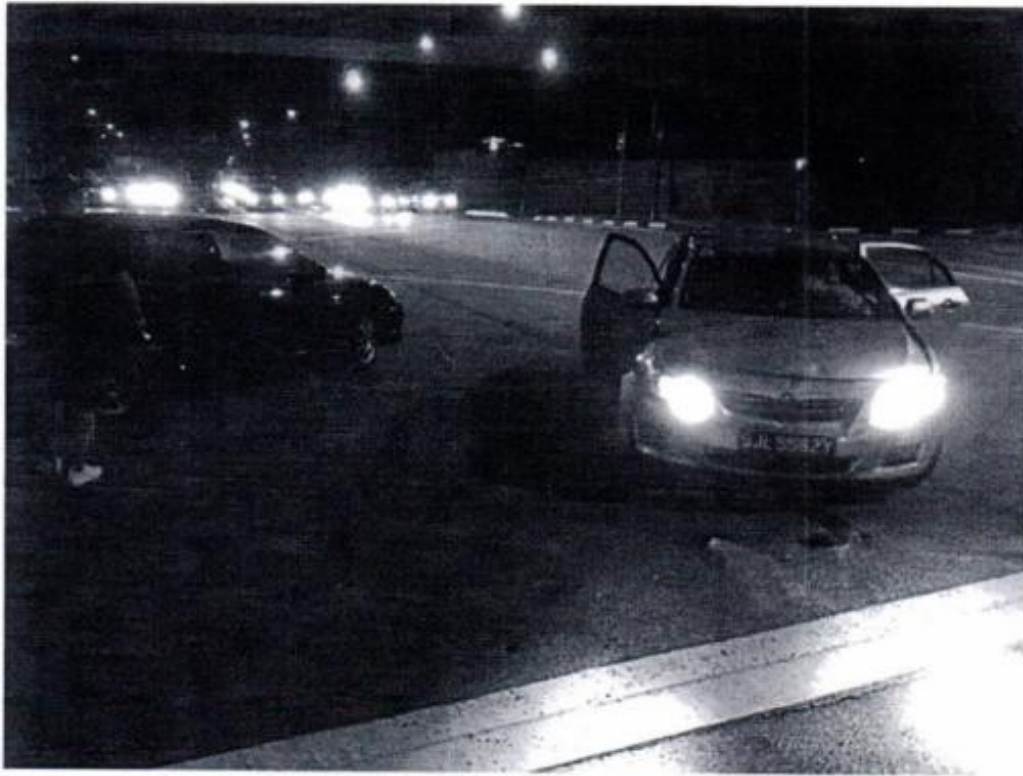

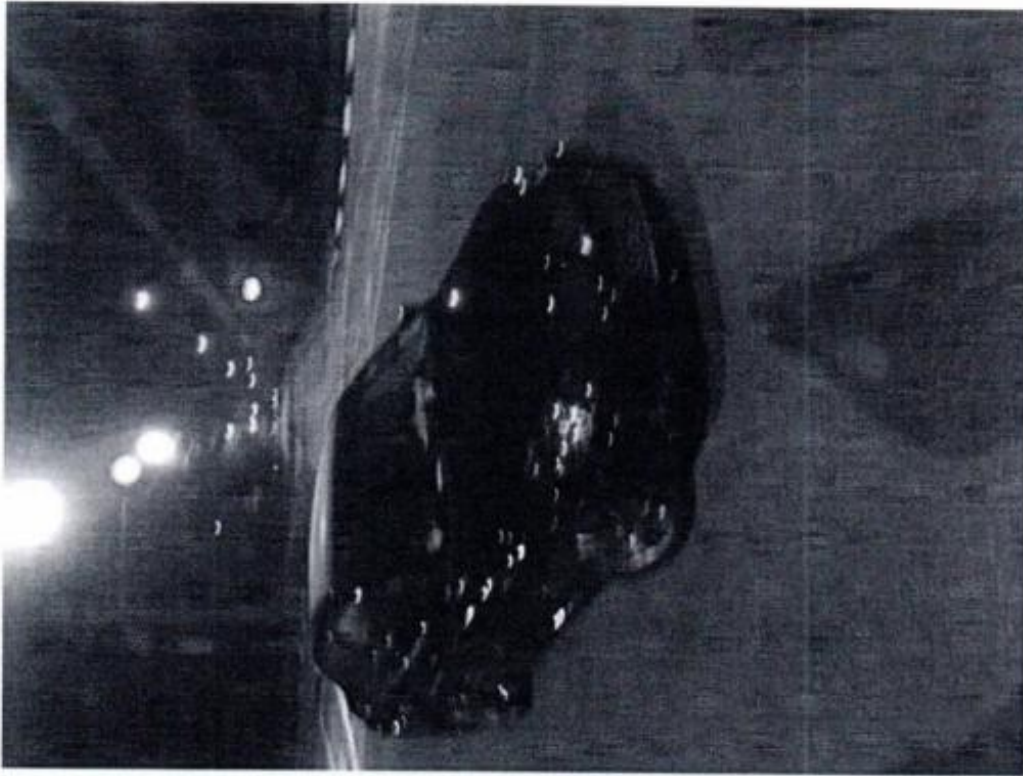

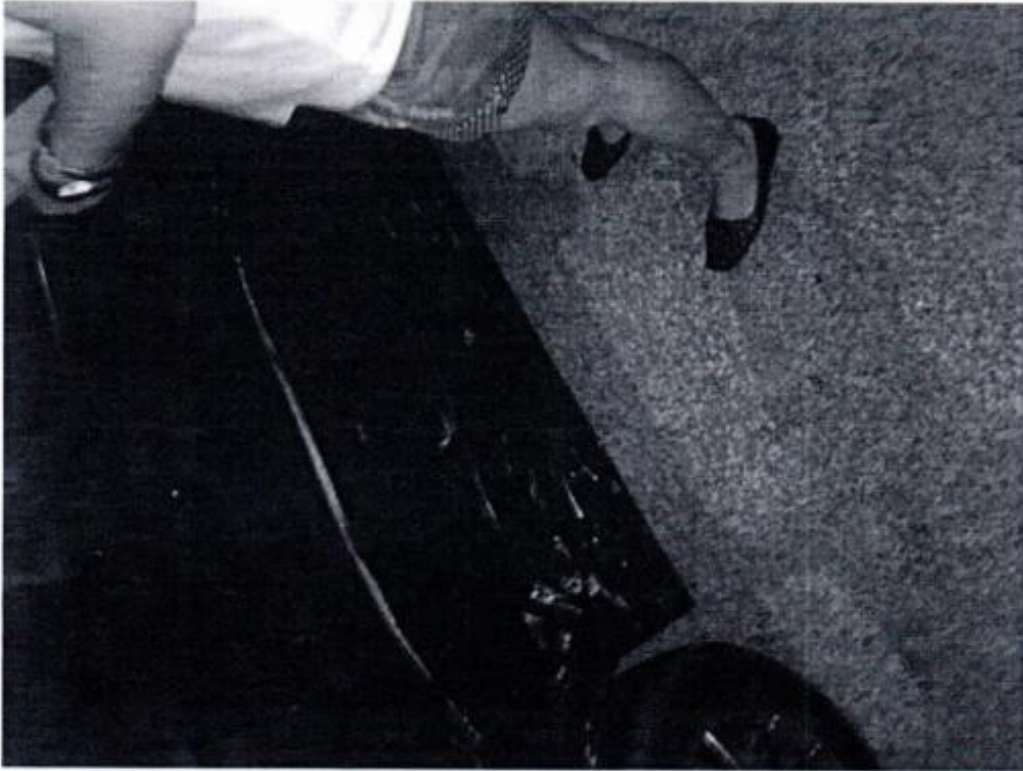
