We would like to update you that we have spoken to insured.

Insured informed us that he did not pursue third-party claim against the claimant and paid his repair from his own pocket.

Insured also confirmed that the claimant acknowledge his fault through sms in which he included screenshots in his statement.

We have given our opinion to the repairer in which we mentioned that according to our insured driver, his door was already opened when their client failed to take evasive action to avoid collision, instead, their client continued to drive and did not keep a proper lookout for our insured's stationary vehicle. TP claimant likewise, did not maintain a margin of safety when passing, hitting the already opened door of our insured. Furthermore, TP claimant acknowledged his liability.
