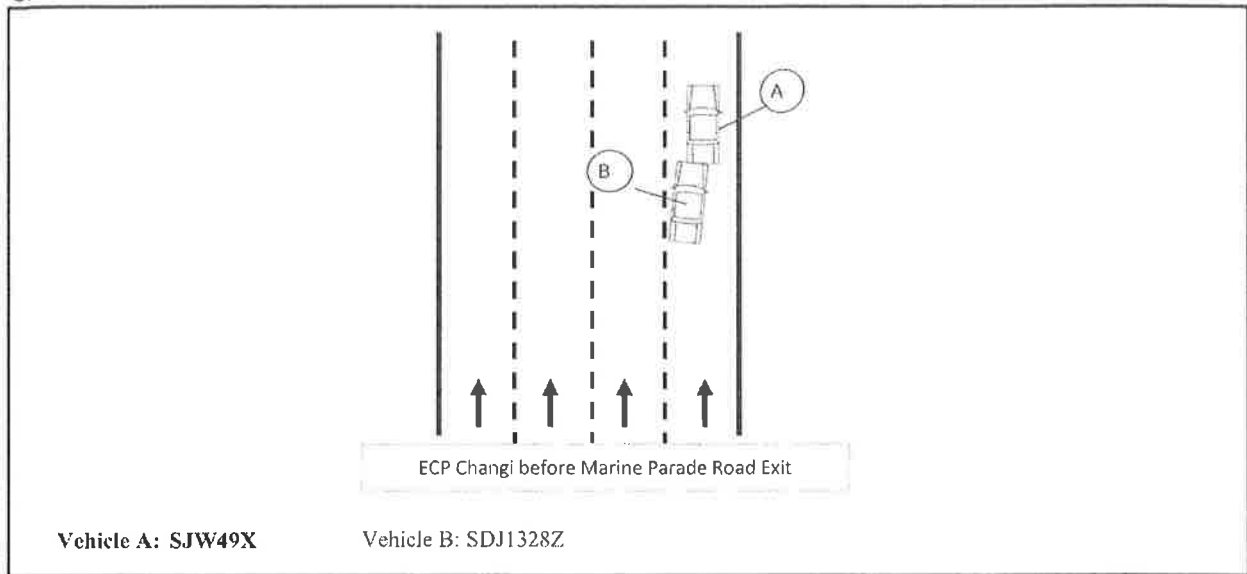

SKETCH PLAN


