Describe Circumstance of the Accident.

ON 27/05/2018 AT ABOUT 1035 HRS, I WAS DRIVING MY TAXI (**SHC 6716 T**) TRAVELLING ALONG PASIR RIS DRIVE 1 AT THE TRAFFIC LIGHT JUNCTION OF PASIR RIS DRIVE 10, WITH A PASSENGER ONBOARD, IN LANE 1.

TRAFFIC LIGHT SHOWED GREEN ARROW ON MY ROUTE FAVOUR & I PROCEED AHEAD – MAKING MY RIGHT TURN INTO PASIR RIS DRIVE 10 – WITHIN MY LANE, BUT SUDDENLY VEHICLE B (**GBF 9819 R- NISSAN VAN**) WHICH WAS APPROACHING IN LANE 2 – HAD ENCROACHED ONTO MY PATH ON MY FRONT LEFT ABRUPTLY.

AS SUCH, THE RIGHT PORTION OF VEHICLE B COLLIDED ONTO THE FRONT LEFT PORTION OF MY TAXI.

DUE TO THE IMPACT, MY TAXI HAD DAMAGES ON THE FRONT LEFT PORTION AND VEHICLE B HAD DAMAGES ON THE RIGHT PORTION.

NO INJURY INVOLVED.

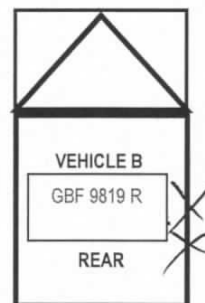
