Sketch Plan



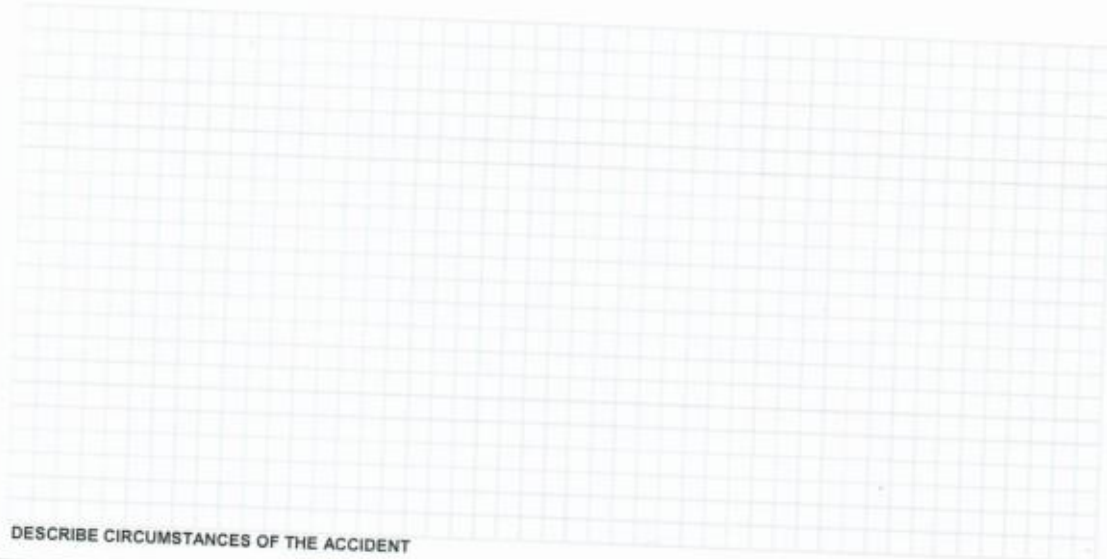
