Please be informed that our Insured had reported that while he was about to make a U-turn, his vehicle was hit at the rear by your client's vehicle. Please see below statement.

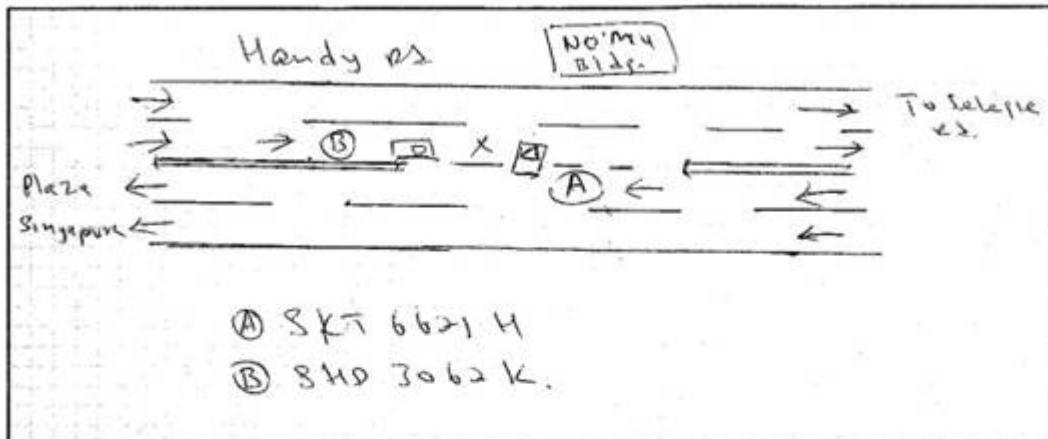
As such, in view of conflicting versions, we would like to request for any evidence e.g. video footage for our further action.
