Describe Circumstance of the Accident.

ON 30/05/2018 AT ABOUT 1625 HRS, I WAS DRIVING MY TAXI (SHB 8616 R) TRAVELLING ALONG QUEENS STREET – TOWARDS THE TRAFFIC LIGHT JUNCTION OF MIDDLE ROAD, IN THE RIGHT LANE.

I STOPPED MY TAXI AS VEHICLES AHEAD OF ME STOPPED & PROCEED AHEAD WHEN TRAFFIC LIGHT TURNED GREEN ON MY ROUTE FAVOUR BUT SUDDENLY VEHICLE B (SCX 787 B – LAND ROVER) WHICH WAS INITIALLY IN THE MIDDLE LANE, FAILED TO KEEP FOR PROPER LOOK OUT, HAD ENCROACHED ONTO MY PATH ON MY LEFT ABRUPTLY.



AS A RESULT, I FELT SOME DISCOMFORT & WILL SEEK FOR MEDICAL TREATMENT SOON. NO AMBULANCE AT SCENE.
