SKETCH PLAN

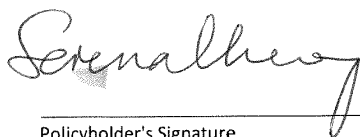
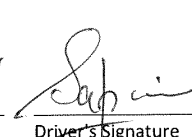
