

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was traveling along Hougang Ave 7, the traffic light was green in my favour.
Suddenly Vehicle B coming from Hougang Ave 5 hit onto my right rear.
Vehicle A : GBG 4150 M
Vehicle B : SHC 5156 R

Based on the documents at hand, we observed that Insured vehicle was proceeding with green traffic light while the TP vehicle had already crossed the stop line to make a turn from the minor road without checking the oncoming vehicles on the main road.



As such, we are of the view that Insured vehicle had the right of way when crossing the junction.

As such, we opine that liability is down against your client and we have our principal's instruction to reject the claim and we are unable to look into your client's claim.

We will proceed to close file accordingly.
