

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 31.05.2018 at about 08:45 Hrs, I was traveling along Havelock Rd towards Church St
with no passenger on board.
Just after I crossed the junction with New Market Rd, I switched on left signal to alert others
on my intention. Then, I slowly filtered to left hand side after ensure the traffic is clear.
When I was about to enter the lane, suddenly veh (B) (SHA 4613E) came out from my left
and thus collided onto my taxi (A) left front portion. As it took place so fast, I could not take
evasive action to prevent the collision.
I had company video fixed in my taxi and photos taken at scene to support my claims.

Nobody was conveyed by the ambulance as no injury at that point of time.
