TERMS & CONDITIONS

Net Link Leasing Pte Ltd (hereinafter called "the Owner" which expression shall where the context so admits include the owner's successors-in-title) hereby agrees to lease and the Hirer named herein (hereinafter called "the Hirer") agrees to take on lease the motor vehicle described herein (hereinafter called "the Vehicle") which can only be driven by the person who has been expressly authorised by the Hirer therein (hereinafter called "the Authorised Driver") subject to the following Terms and Conditions :

- The Hirer is to furnish any additional driver's particulars in advance for the Owner's approval.
- Unless with written consent from the Owner, any driver below 21 years old or with less than 1 year of valid Singapore driving licence is not allowed to drive the Vehicle.
- In the event that the Vehicle or any part thereof is damaged as a result of any accident, the Hirer must report to the Owner immediately without fail, otherwise S\$500 penalty will be imposed to the Hirer for creating an unfavourable standpoint to the Owner in terms of insurance claim's perspective.
- For any accident that happens regardless of whether the driver of the Vehicle is at fault or not, the Hirer unconditionally agrees to pay the Owner following payment(s) within 5 calendar days upon the date of accident :
 - S\$3,500 for driver who is 22 years old (or older) and with minimum 2 years of valid Singapore driving licence.
 - S\$7,000 for driver who is 21 years old or with minimum 1 year of valid Singapore driving licence.
 - S\$12,000 for driver who is below 21 years old or with less than 1 year of valid Singapore driving licence.
 - Additional payment of S\$1,000 for driver who is under work pass regardless of age and years of valid Singapore driving licence.These payments comprise of insurance excess payable and compensation to the Owner for impact of claim on future motor insurance renewal premium. These payments will only be refunded back to the Hirer upon 100% successful claim against the Third Party or Third Party's insurer.
- The Hirer is also fully liable for all loss and damages not recoverable under the Owner's Vehicle policy of insurance including any Third Party's claims, loss of earnings while damaged Vehicle is under repair and subject to Owner's discretion, the full repair costs or market value of the Vehicle before incident.
- The Owner is in absolute discretion to conduct any negotiations and effect any settlement with the Owner's insurer, Third Party and Third Party's insurer.
- Replacement of vehicle will not be provided for any accident case regardless of whether the driver of the Vehicle is at fault or not.
- Only petrol/DIESEL from petrol station is allowed, failing to comply may cause engine failure/damage, hence the Hirer is fully liable for the total damage/restoration costs.
- The Hirer and the Authorised Driver have to ensure that the Vehicle is equipped with sufficient fuel, engine oil, coolant/water and prescribed tyre pressure at all times. The Authorised Driver should also stop driving and inform the Owner immediately if the Vehicle's meter is showing high temperature. Failing to do the abovementioned items the Hirer will be fully liable for the full cost of repairs including loss of income arising from the Hirer's or the Authorised Driver's negligence.
- The Hirer and the Authorised Driver are responsible for sending the Vehicle to the Owner's authorised agents for regular servicing/maintenance and repair/replacement of any wear and tear item including tyre and battery. Failure to do so may cause the Vehicle to break down, engine failure/damage as well as traffic accidents, hence the Hirer is fully liable for the total repair, overhaul and restoration costs. In addition, the Owner reserves the right to repossess the Vehicle as deemed fit and terminate the agreement without any liability to the Hirer. The above-mentioned regular servicing/maintenance is based on :
 - ☐ 5,000 km or 3 months (from the servicing date as stated on the decal), whichever comes first
 - ☐ 10,000 km or 6 months (from the servicing date as stated on the decal), whichever comes first
