On 3 March 2018 at about 5.58 pm, the involved party (B1) was travelling along Yishun Ring Road towards Yishun Avenue 11 on the left of 2 lanes road. He claimed A1 who was travelling in front of his vehicle made a sudden brake and stopped. As such, he made a lane change to the right to overtake A1. In the midst of overtaking, suddenly the deceased crossed the road in front of A1 and appeared on his left to right. B1 could not avoid and collided onto the deceased's right side. Due to the accident, the deceased was injured and was conveyed conscious to Khoo Teck Puat Hospital (KTPH) by ambulance. The deceased was warded at ICU Ward B36 Bed 15. The deceased then succumbed to her injuries in hospital and was pronounced dead on 4 March 2018 by Dr Cadence Wee at 1228 hrs at KTPH ICU.
