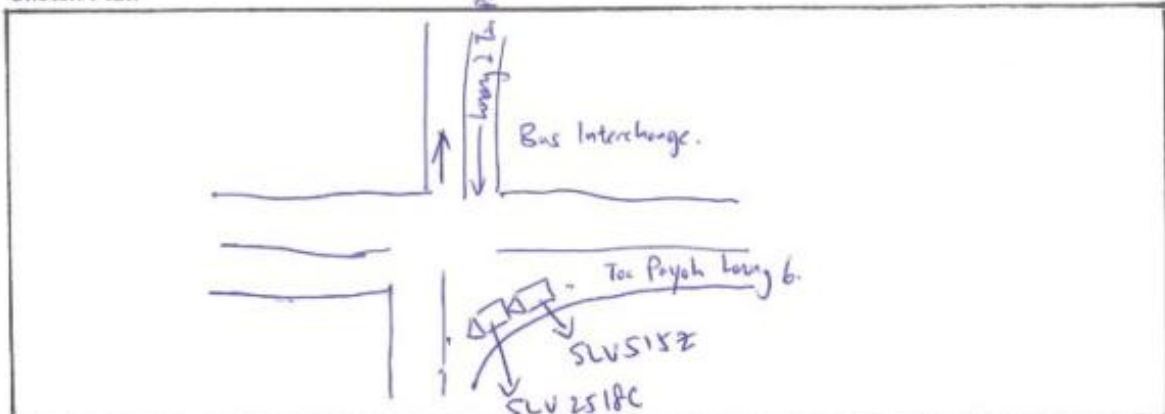

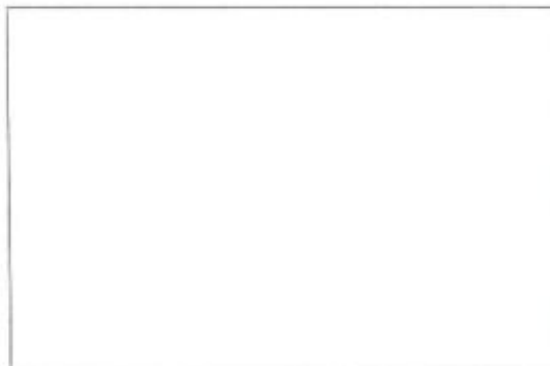

3. Lodge a police report for the following motor accident cases:-

 - any accident outside of Singapore.
4. Avoid all unauthorised tow-truck operators or repair workshops.
