ON THE ABOVE MENTIONED DATE TIME AND LOCATION

I WAS TRAVELLING ALONG BUKIT BATOK WEST AVE6 TOWARDS BUKIT TIMAH ROAD, I WAS ON THE RIGHT LANE.
