**Brief details.**

On 3 June 2018 at about 15:44 there about, I was driving along Sims Avenue, a 4 lane carriage way. I was on L1 and signalled and waited to filter to my left lane (L2). From my rear mirror, I saw SJJ 3925R and further back it was SHD 3037J (the Taxi that hit me from my left).

I signalled and waited to let SJJ 3925R pass first as I need to filter to L2.

After the SJJ 3925R passed me, it was clear in L2 that I am filtering into. SJJ 3925R passes me and the

lane was clear.

My car begins to filter into L2 as the lane markings are at an angle to my car as shown above.

From this video grab it showed that my car is fully in L2 and driving straight as the lane markings are parallel to my car.

SJJ 3925R is way ahead of me at about this time and I am fully in the lane driving straight already.

The lane markings are parallel to my car as the video showed above.

If the lane markings were at an angle to my car that would have indicated that I haven't filtered into L2 and got hit. I was travelling straight ahead in L2 before getting hit. Then I got hit from the left and the damage was on my left rear passenger door.

Between the split seconds of 15:44:24 and 25 per the time prints in the video (attached) above, was about when taxi SHD 3037J hit me as the crash sound could be heard in the video.

It appeared to me that SHD 3037J must have filtered right from L3 or L4 to my lane (L2) as I was already driving straight after getting into L2. The damage on SHD 3037J clearly showed that he hit me from his right as there was scratches on the front right (near the head lamp). My rear end was also not even damaged.

We then drove further ahead to not block traffic and exchanged details and agreed to make reports.

From the damages of my car taken at site, it is evident that SHD 3037J must have filtered into Lane 2 from Lane 3 as when I saw him in my back mirror he was very far away.

From pictures taken at site, the damage on SHD 3037J showed only his right front bumper near the head lamp thereabout made contact with my car. His front bumper and grille are all intact. It showed it was a front side impact onto my car left rear passenger door.

Close-up pictures (see attachment) of damages on my car taken at my residence, the damages were all on the left back door and the left rear side thereafter. There was no damage on my rear bumper which showed that the driver of SHD 3037J was not behind me but came from the left Lane 3 due to his filtering.

I have the video of the incident, please tell me how to attach it or present it? Thank you.

That is all I have to say and can remember at this point.
