

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

The accident happen on first lane of PIE expressway <sup>before</sup> near Eunos Link Exit at <sup>about</sup> 2010 hours. Earlier on there were heavy buildup of traffic on the PIE expressway. Thus, I was only travelling at a snail pace. However, traffic starts to clear up and I could see the front vehicle moving at normal speed. I follow suit but moments later I saw him slow down and I also reduce my speed. At that moment, I ~~would feel a slight bang~~ ~~or~~ behind was hit from behind by a taxi (SHA 1728 C). I noticed he (taxi driver) had been tailgating me all this while before impact.
