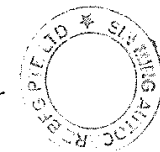

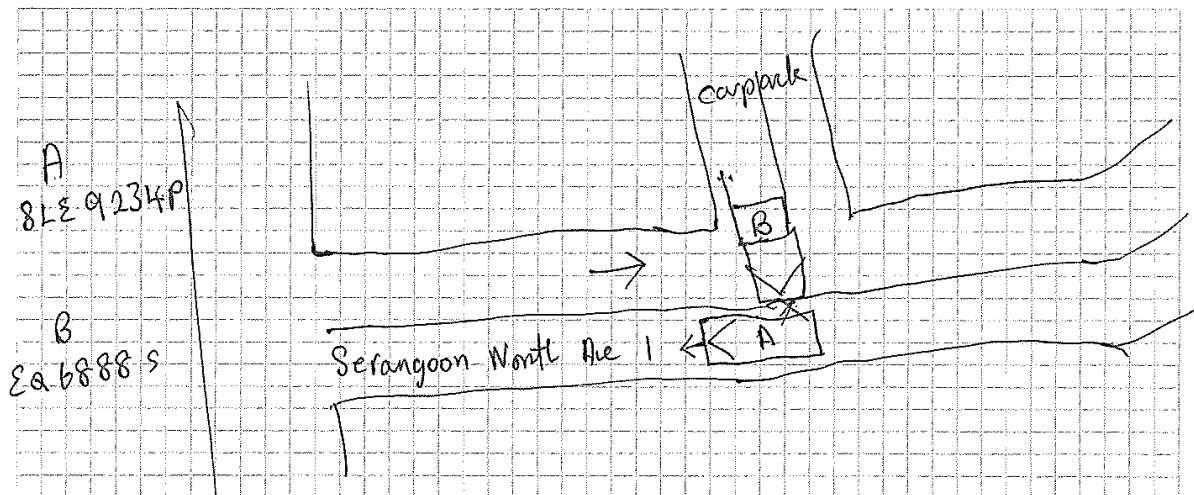

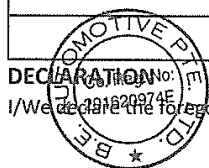


SKETCH PLAN
