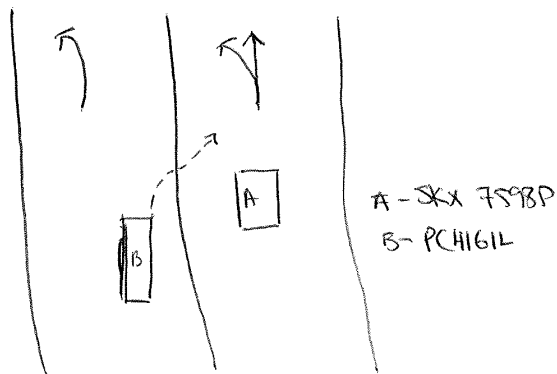

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

was driving along AYE before Alexander exit and ERP, was going to turn left towards exit^{on} but coach PC41611K from the lane on my left cut into my lane. When the coach got too close, I stopped my vehicle and horned but the coach continued to move forward and thus came into contact with the front left hand fender and bumper of SKX759BP.

After the collision, the coach continued to drive off with no intention to stop after the collision. Subsequently contacted the TP and was advised not to pursue as the details of the coach license number was noted.
