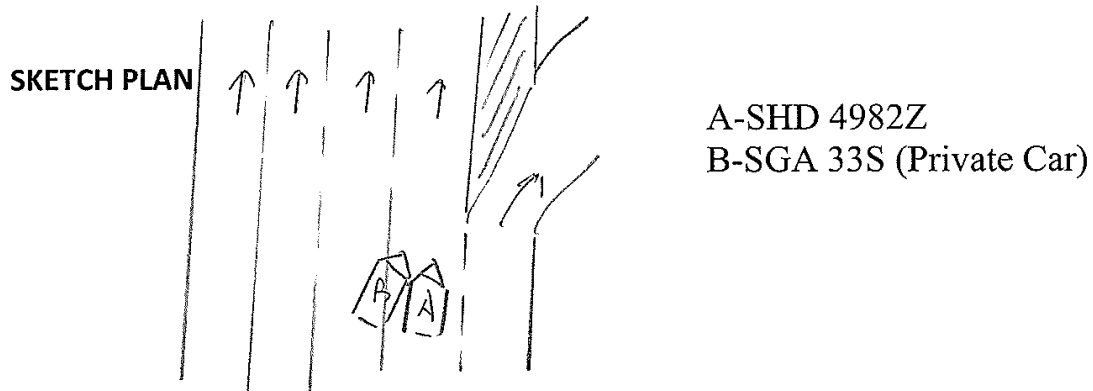

Describe Circumstances of the Accident

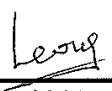
On 2/6/2018 @ 16:10hrs,I was driving along Orchard BLVD twds
